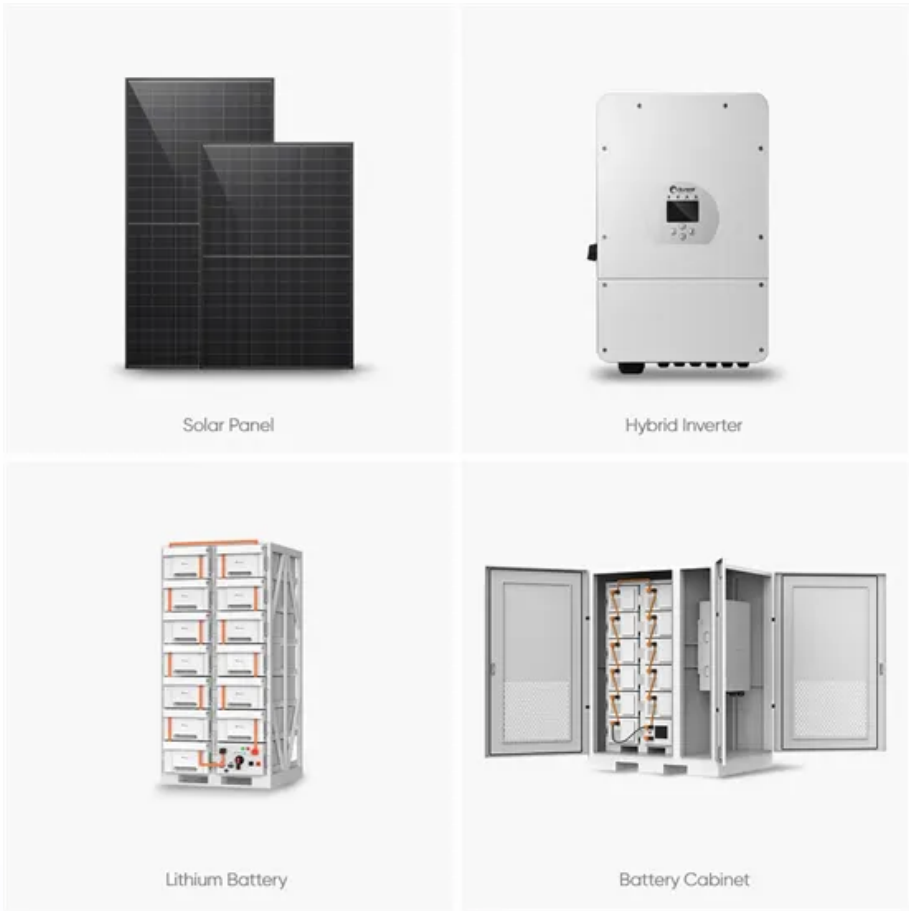

Overview

Depending on the specific facts and circumstances of a suspended company, under GEM Rules 9.15, (a) the Exchange may at any time publish a delisting notice stating its right to delist the company if it fails to resume trading within a shorter period.
